## HOUSE RULES OF THE COMMON MARKET LAW REVIEW (2025)

The Common Market Law Review is conscious of its position as the oldest specialized review in the field of European law, and of its avowed aim to promote academic discussion which goes across national boundaries. With this in mind, we ask our authors to make a special effort to acquaint themselves with the academic discussion on their particular topic in countries other than their home State. Only in this way are we able to offer our readers the highest level of intellectual and legal analysis, and to achieve real developments in a particular debate.

## 1. SUBMISSION OF MANUSCRIPTS

- 1.1 Articles and case annotations should be submitted to the Managing Editor, Ms Anna Krisztian, in Word format, at <u>CMLRev@law.leidenuniv.nl</u>. Inquiries and proposals should be sent to the Managing Editor at the same email address.
- 1.2 Articles should preferably have 12,000-15,000 words including footnotes. Annotations should be around 8,000 words including footnotes.
- 1.3 Authors should provide confirmation that the article or annotation has not been published, nor is pending publication or under consideration elsewhere.
- 1.4 Articles should be accompanied by an abstract of around 150 words (8 lines). Keywords should also be listed.
- 1.5 In the absence of a declaration otherwise, co-authorship means that the authors assume joint responsibility for the whole text of the manuscript.
- 1.6 Correspondence related to book reviews should be sent to <u>cmlrev-books@law.leidenuniv.nl</u>.
   Books reviews should be 1-3 pages in length, and contain no footnotes.

# 2. GENERAL RULES OF CITATION

2.1 References of accepted manuscripts should adhere to the citation rules of OSCOLA, except for CJEU cases, which should follow this format:
Case C-646/21, K, L v Staatssecretaris van Justitie en Veiligheid, EU:C:2024:487; Opinion of AG Szpunar in Case C-597/19, M.I.C.M. (Mircom), EU:C:2020:1063, para 98.

Where CJEU cases are referenced in several footnotes, please use the short case name and the case number in subsequent footnotes (e.g. Case C-360/09, *Pfleiderer*).

### 3. SPECIFIC POINTS OF STYLE

- 3.1 Please give annotations an explanatory title. The second half of the title can consist of the (short) name of the case.
- 3.2 Useful subdivisions of annotations are:

Introduction Factual (and legal) background Opinion of the Advocate General (as required) Judgment of the Court Analysis / Comment Conclusion

## 4. COPYRIGHT AND OFFPRINTS

Kluwer Law International requests from its authors an exclusive licence to publish. Authors will be requested to complete the publisher's form concerning grant of exclusive licence.

Authors may self-archive their work on non-commercial websites after 6 months following its date of publication in the Review, with due reference to the original publication.

Authors of articles and annotations receive one copy of the issue in which the contribution appears and digital offprints. Authors of book reviews receive digital offprints of their review.
